PUBLIC SERVICE ANNOUNCEMENT FROM ANETH JUDICIAL DISTRICT

The Aneth Judicial District facility is closed from September 13, 2021 at 5 p.m. to September 16, 2021, at 8 a.m.

The drop box at the Aneth Judicial District Court is not available until further notice; however, Shiprock Judicial District will accept documents through its drop box in Shiprock if necessary.
